GOVERNMENT EXPENDITURE ON ABORTION

November 2023





Overview

The government does not publish clear numbers on the total expenditure on abortion, which encompasses a wide range of categories. Answers sought by TDs via Parliamentary Questions (PQs) to the Minister for Health which asked for the total expenditure have produced incomplete and often confusing statements.

This report attempts to piece the jigsaw together by drawing on all the information from the series of parliamentary questions to give an estimate of the scale of state spending on abortion provision, from 1st January 2019 to 30 June 2023.

From the available data, this report has calculated through PQs that an estimated €45,928,018 has been spent on "abortion services" in the aftermath of the 2018 referendum.

It's quite likely that this is in fact an underestimation of the total spending, but it presents the sum total of the money which has been disclosed in PQ replies.

The colossal bill has been racked up in just 4.5 years. Meanwhile, not a cent has been spent on promoting positive alternatives for women in unplanned pregnancies. Agencies like the State-run MyOptions hotline operate like a de facto abortion referral service. Its staff, for example, are not trained or equipped to meet the needs of women who are conflicted about having an abortion and are seeking practical support and information about alternatives to abortion.

Senior members of government promised the electorate prior to the referendum in 2018 that abortion would be "rare" in the event of people voting for repeal. The fact the government has spent an estimated €45,928,018 of taxpayers' money since 2019 bankrolling the ending of human life by abortion is an outrage. Some members of government and the media balk at abortion provision in Ireland being referred to as the "abortion industry", but it's hard to find fault with this description when one takes an honest look at the obscene amounts of money being spent to end the lives of unborn babies.

The Pro Life Campaign has repeatedly called for more openness, transparency and public discussion on what precisely is happening under the new abortion regime, including with regard to the exact amount of taxpayers' money being used to fund abortion provision across the country. The public are entitled to this information and it shouldn't fall to groups like ourselves to have to piece together information from multiple sources to provide a clearer picture.

Perhaps the government doesn't want the public to know the amounts being spent as they certainly cannot stand over the indefensible expenditure of €46 million on abortion provision, while refusing to spend a single cent on the promotion of positive alternatives to abortion. The government's disgraceful misuse of public funds on abortion and the free rein they've given to the most extreme elements of the pro-abortion movement to promote the ending of human life guarantees that abortion will be an election issue in 2024.
